NPDES Level 1A Fundamentals Certification (Blue Card)

August 4 ♦ Atlanta

If you have taken this course in the past and card is expired, you only need the 4-hour recertification class which can be taken on-line or in-seat training at the AGC offices.

The Level 1A Fundamental Seminar and exam is a one-day course ending with the Level 1A certification exam. The course is designed to train contractors, builders, developers, site superintendents, utility and grading contractors, and monitor consultants in the proper installation, maintenance, and inspection of BMP's on construction sites.

Topics covered in this course are fundamentals of erosion and sediment control, the Georgia Erosion and Sedimentation Act, NPDES Permits, maintenance, stream buffers, vegetative and structural BMP practices.

Attendees will receive blue cards after passing exam.

Scaffold Safety – Competent Person Training

August 7 ♦ Atlanta

The Occupational Safety and Health Administration (OSHA) requires a competent person to supervise when a scaffold is "erected, moved, dismantled, or altered," 1926.451 (a)(4). Participants in this course will be provided the necessary training to be considered a "competent person" by an OSHA inspector. The instructor will also cover the most common OSHA violations related to scaffolds and how to control/eliminate accidents and injuries associated with scaffolds.

- When to tie scaffolding to a building
- Platforms and planking
- Fall protection
- Ladders and stairways
- Systems scaffold

NPDES Recertification for all Levels

This course is for anyone who has ever passed the exam and needs recertification. Includes those who have expired cards.

Fall Protection – Competent Person Training

Falls are the leading cause of worker fatalities in construction. The top four OSHA citations are fall-related. Each year, on average, between 150 and 200 workers are killed and more than 100,000 are injured as a result of falls at construction sites.

Employers have a duty to provide fall protection when employees are at risk of falling 6 feet or more and at least one Fall Protection Competent Person per trade should be identified on a project if their workers are exposed to fall hazards. This course will provide participants training and knowledge of OSHA's Subpart M in identifying fall hazards and how to eliminate the risks of falls.

OSHA 30-Hour Construction Safety

September 22, 23, 24, and 25 ♦ Atlanta

Many owners and general contractors are now requiring that contractors complete the OSHA 30-Hour Construction Safety Outreach course prior to working on their projects. The class is OSHA's main method of training site workers and management.

This four-day course is a comprehensive safety program designed for anyone in the construction industry. It is developed for the person who works with a broad variety of construction standards. The class covers the full spectrum of construction safety from Subpart A through Subpart Z. Learn how to recognize basic construction hazards and implement corrective measures through classroom instruction.

Upon successful course completion, attendees will receive an OSHA 30-Hour Construction Outreach Course completion card.

Basic Blueprint Reading

This course offers not only the basics of blueprint reading, but also the fundamentals of construction methods that make blueprint reading meaningful. This course will offer basic descriptions of pictorial drawings, construction materials, construction specs, how to use a scale, and reading plot plans. It will also cover the basics of print reading for concrete footings, structural steel framing, welding, unit masonry construction, framing and finish, plumbing systems, air conditioning systems and electrical systems.

Bloodborne Pathogens: Topics of this module include definition, prevention, universal precautions, immunization, exposure control, and post-exposure reporting.
