- 1) AGC members receive a **National AGC Safety Award** (NASA) by meeting the following criteria:
 - ◆ Participated in NASA Program for 3 consecutive years
- 2) AGC members receive an **AGC of America Zero Incidence Rate Award** by meeting the following criteria:
 - ◆ Same as #1; and
 - ◆ Zero lost work day cases for 2015
- 3) AGC members receive an **AGC of America Certificate of Commendation for 25% Below Division Incidence Rate** by meeting the following criteria:
 - ◆ Same as #1; and
 - ◆ 25% below average in each division for the preceding 3 years

- AGC Georgia members receive an **AGC Georgia Safety Award** by meeting the following criteria:
- ◆ AGC Georgia member with jobsite labor
 - ◆ Zero lost work day cases for 2015
