## 2016 Legislative Session Results: The Good, The Bad and The Ugly

Mark Woodall, AGC Georgia's Director of Governmental Affairs, is visiting with members across the state to share the *good, the bad and the ugly...* and how new laws and regulations from the 2016 legislative session affect you and your company.

A core principle of the entire AGC organization is "less government is better." Our primary legislative agenda is to always play defense against many well-intended proposals that can lead to bad public policy. In the 2016 session, we were intimately involved in the passage of a number of pro-active industry bills, including House Bill 402, which promoted workforce development, and Senate Bill 191, which promoted uniform requirements under the Call Before You Dig Law.

HB 402 (effective July 1, 2016) is a great piece of legislation for the construction industry's workforce development efforts. AGC Georgia proudly served as a resource to legislators during the development of this bill and testified in its favor because it allows for new opportunities to introduce more young people to careers in construction. The bill clarifies that contractors are legally able to provide work-based learning opportunities for 16 and 17 year old students in sanctioned workforce development programs. The incentive in the new law provides employers who hire these students with an optional 5 percent reduction in workers' comp premiums.

SB 191 was in play for the 2015 and 2016 legislative sessions. An amendment to the bill was made earlier this year by the Georgia Utilities Coordinating Council (GUCC) in an effort to address the issue of local government adopting and enforcing different standards

Gov. Deal signed HB 402 (Act 356) into law in May and it is effective July 1. AGC Georgia participated in the signing ceremony with bill sponsors and representatives from the Lt. Governor's Office, Georgia DOE and representatives from CTAE.

regarding white lining requirements under Georgia's Call Before You Dig law. SB 191 extended a dig ticket life from 21 to 30 days. Included in GUCC were local government, utilities, PSC and contractor organizations, including AGC Georgia. We specifically advocated for SB 191 because it recognizes a single statewide standard instead of the need to operate under multiple and varying local government standards.

SB 326 and SB 437 were introduced this session to generate discussion among the various stakeholders during the legislative off-season. SB 326 amends the Soil and Erosion Control law by reducing the period of time local plan reviewers have to review soil and erosion control

plans (NPDES) from 45 to 14 days. As developed, SB 326 would have also required plan reviewers to hold the same credentials as those who develop the soil and erosion control plans.

SB 437 addressed concerns with current law governing private plan review and inspection services. Many jurisdictions are taking entirely too long to provide plan review services. While Georgia law does allow for private plan review and inspection services, the current law is not being utilized because of the cost and time frames outlined in the code. AGC Georgia advised the Senate sponsors of both SB 326 and SB 437 that we are very interested in working on these issues with our partners in state and local government in preparation for the 2017 legislative session.
